ROLL OFF SCHEDULE

DAY 1 - 7 GAMES Bowlarama Wetherill Park - Saturday 22nd February 2025 Check in 9.00am

Failure to check in by the required time on the first day of the trials will result in automatic disqualification.

DAY 2 - 7 GAMES Windsor Tenpin Bowl - Sunday 23rd February 2025 Check in 9.00am

Late arrivals on the second day will be permitted to bowl but the score will be zero for all frames missed. Any games affected by missed frames will be counted towards the 'Trails averages' used at the Carnival.

SELECTION OF TEAMS

At the completion of the 14 games, the tournament Committee will announce the teams for both the Restricted and Classic Challenges, based upon the following;

1) HOLT RESTRICTED CHALLENGE TEAM

The top seven (7) female and male bowlers on total score with handicap will be declared the NSW Holt Restricted Challenge Team for the current year.

- a. In the event of a tie for either the final position or first position in either division, a one (1) game playoff will be conducted with the winner taking the higher position.
- b. Handicap shall be applied as normal to the playoff game.

2) HOLT CLASSIC CHALLENGE TEAM

The top four (4) male, and top Three (3) female bowlers based on total scratch score only will be declared the NSW Holt Classic Challenge Team for the current year.

a. In the event of a tie for either the final position or first position in either division, a one (1) game playoff will be conducted with the winner taking the higher position.

3) REPRESENTATION AT TROPHY EVENTS

The top qualifier in each team, male and female will earn the right to represent the zone at the relevant trophy event during the current year's Holt Tenpin Bowling Carnival.

THE HOLT TENPIN BOWLING CARNIVAL

The 2025 Holt Challenge Teams will be competing in the Holt Tenpin Bowling Carnival to be conducted at Warwick Super Bowl WA between 9th August and 21st August 2025. All bowlers who are not successful in making the teams are welcome to attend the Holt Tenpin bowling carnival to participate in the other events including graded squads, various Masters and the John Dobson Memorial event.

MEMBERSHIP FEES

Every bowler who wishes to Roll-off for the NSW Holt Teams will be required to be a financial NSW Holt member as well as a TBA member. The membership fee for 2025 will be \$15 and must be paid upon application to the committee prior to the date of the 2025 NSW Roll-off.

Failure to pay the Membership fee prior to the roll off may exclude you from Rolling-off.

CARNIVAL COSTS

The following Information is applicable to both Classic and Restricted Teams should you be successful in making a team. It should be taken into consideration when deciding to bowl at the Holt Challenge Tournament. These costs will also apply to Team Officials when they are appointed.

Cost for Challenge Teams will include but may not be limited to: Tournament Registration fees, All Events entries, Dinner Dance Tickets, Lunch (during Challenge Event) and team uniform.

Accommodation, ground travel to venue, travel to and from Warwick Super Bowl, meal expenses and any additional expenses outside of the tournament is the responsibility of the team member.

Should a bowler be successful in making a team, they will be required to make payments per the following schedule. (A higher cost if successful for 2 Teams)

Initial Deposit - \$200 / \$300 – due on or before Sunday 16th March 2025

First Instalment - \$300 / \$400 – due on or before Sunday 13th April 2025

Second Instalment - \$300 / \$400 – due on or before Sunday 11th May 2025

Third Instalment - \$300 / \$400 – due on or before Sunday 8th June 2025

FINAL Payment - BALANCE – due on or before Sunday 6th July 2025



These costs are based on past expenses and estimates. You will be given further details in an official Invoice when total costs have been determined.



If **ANY** Payment **CANNOT** be met by the due date **WITHOUT** prior notice, the person involved may be deemed ineligible to participate in the Holt Challenge for the current year.

YOU MUST NOTIFY NSW Holt Committee member immediately when you become aware you are unable to meet a payment deadline.

TRAINING SESSIONS

A number of training sessions will be organised over the months leading up to the Holt Challenge in August. Dates to be advised. It is expected that bowlers will attend a majority of these training sessions.

It is **COMPULSORY** for **ALL** team Members to participate in the John Laver Memorial Scotch Doubles to be held in July 2025.

To promote Holt NSW, **ALL** Team Members are expected to find a partner who is **NOT** already a Holt NSW Member.

ELIGIBILITY FOR NSW HOLT CHALLENGE TEAMS

Nomination is open to ALL bowlers meeting eligibility criteria

- 1) For both tournaments
 - a. Be a resident in the Zone for which the roll-off is being held
 - b. Have attained, or will attain, the age of 18 years on, or prior to the first day of the Holt Tenpin Carnival in the current year.
 - c. Have competed in at least eight (8) weeks of league competition, bowling a minimum of twenty-four (24) games in a single league in a Centre, within the Zone for which the roll-off is being held.
 - d. Be a financial member in good standing with both **TBA and NSW Holt Challenge**.
- 2) For the Restricted tournament:
 - a. Male bowlers must not have an average exceeding 184
 - b. Female bowlers must not have an average exceeding 174
- 3) For the Classic tournament:
 - a. Male bowlers must not have an average exceeding 199
 - b. Female bowlers must not have an average exceeding 195

AVERAGE

The competitor must not have any league average, including touring leagues etc, over a minimum of 24 games at the end of any league season in the preceding year [2024] exceeding the maximum averages as listed above. **ALL averages** must be disclosed [including any league seasons that may not have ended or been completed]. Failure to do so may result in disqualification. Entering averages may be subject to re-grading at the discretion of the NSW Holt Committee. Re-grading may be based on previous Holt Carnival performances and Championships bowled during 2024.

HANDICAP

Handicap will be applicable to bowlers' scores when used towards the Restricted team, and shall be 100% of the difference between the bowler's average and a threshold of 200

SMOKING and CONSUMPTION OF ALCOHOL

Smoking, and the Consumption of Alcohol, is prohibited whilst the Trials are in progress and until the last ball is bowled on each day.

DISPUTES

Any disputes or complaints must be lodged with the Committee and/or Tournament Director within fifteen minutes of the alleged infringement.

BOWLING ATTIRE

All bowlers are required to wear a collared shirt and tailored pants/shorts/skirts. Bowlers must present in neat and tidy bowling attire with NO jeans, hats, stubbies or football shorts, tights, cargo or track pants to be worn whilst competing without the approval of the Committee

GENERAL RULES AND INFORMATION

- 1) All TBA Tournament Rules & Regulations will apply
- 2) Any Holt Challenge specific rules apply
- 3) Any matters not covered in the conditions will be decided by the Tournament Committee
- 4) If a Team Vacancy arises the spot will be filled by the next available bowler who participated in the roll-offs
- 5) Depending on the outcome of fundraising events throughout the year, individual bowlers will be required to pay all expenses remaining after those funds are allocated.
